



TERMS AND CONDITIONS

Kolkata Kettle organized by Rotary Club of Calcutta Midtown (“Organizers”) will be held on 11 & 12 January, 2024 at 27, Ballygunge Park, Kolkata-19 from 11 am to 8 pm.

1. Stall Exhibitor Deliverables

The Stall Rent includes one billing table (size 3.5 by 1.5 feet), two chairs, two Lights, one plug point and carpet. Food coupons will be given to the participant. Please note that for water, we'll have water dispensers at many locations. This is to reduce the use of plastic as we are an eco-friendly club.

Some more deliverables are:

- 3 full page advertisements in Telegraph.
- Intensive Social Media.
- Foot fall 5000 plus over two days.
- Presence of Celebrities and Luminaries.
- Extensive Media Coverage Print and Digital.
- Workshops and Fashion Show by Nayanika Chatterjee.

2. Table Space Exhibitor Deliverables

Table Space of dimension 5 by 2.6 feet will be given to the table holders.

Table exhibitors can display their goods only on the Table surface. No stands or props will be allowed which occupy floor and air space. If a Table exhibitor gets any or more of these extra items, Organizers reserve the right to remove them.

Banners are not allowed, but, Exhibitor may keep business cards on tables.

3. Payment:

Exhibitors must ensure that full participation fee is paid within 7 working days from the date of the booking. If full payment is not made, the booking can get released to another exhibitor. Incase you want to give cash, we'll provide you with our offices at central areas for you to send money.

Exhibitors need to complete 100% of their payment and collect their possession certificate to be able to exhibit. Only Exhibitors with valid possession certificate will be allowed inside the exhibition ground on the due date.



Exhibitors have to send screen shots of digital payments made to organizers to reconcile.

4. Stall Handover:

The stalls of the Exhibitors will be handed over by 8am on 11th January. They should complete their setup of goods by 10am on 11th January.

5. Stall Allotment

Organizers reserve the right to allot the stall at their sole discretion and they will not entertain any query on the matter.

6. Safety & Security of Goods:

Vendors are responsible for the safety of their own goods and belongings at the venue. If vendors send their goods to our premises before the exhibition they will do so at their own risk. Exhibitors shall bring, display, store and remove their property from the exhibition center at their own risk and shall be responsible for the safety of their property at all times. Organizers will not have any liability for damages to goods caused by any cause arising out of participation in the said exhibition.

The Organizers, its workers or agents shall not be liable for the safety of vendor, their workers, agents, contractors, or invitees during the exhibition nor for any exhibits, articles, or other property of whatever kind brought into the exhibition by the vendor, their servants, agents, contractors, invitees, or member of the public. Organizers shall not in any event, be held responsible for any restriction or conditions which prevent the construction, erection, completion, alternation, or dismantling of stands or the entry, setting or removal of exhibits, or for failure of services or amenities provided by other third parties.

7. Force Majeure

Organizers shall not be liable for cancellation or part time operation of the exhibition, either as a whole or in part, for any non-performance of their obligations to the extent that such occurrence is due to any circumstances not within their control (including, but not limited to account of Act of God, war, insurrection/ bandhs/ government elections/ strikes/ unplanned State or National holidays called by any authority, riots, act of terrorism, earthquake, epidemic, flood, fire, and explosion). In such a case, RCCM shall not be liable to refund any rental payments (or a proportion thereof as appropriate) made by the vendor in relation to the exhibition and RCCM shall not be liable for any losses (including consequential losses), damages, demands, costs, claims, charges or other expenses of any kind howsoever arising in respect thereof.



8. Indemnification

The vendor agrees to indemnify the Organizer on demand against all and any actions, claims, demands, losses (including consequential losses), proceedings, damages, liabilities, costs and expenses incurred by or made against RCCM in connection with the following:

All costs, claims, demands and expenses to which Organizer may in any way be subject as a result of any loss or injury arising to any person (including members of the public or Organizer staff, agents or contractors) or property, howsoever caused, as a result of any act or default of the vendor, his servants, agents, contractors or invitees; or Any act, omission, default, or negligence of or loss or damage caused by the vendor in connection with any other person, the exhibition and the exhibition center; or Any breach or non-compliance of the applicable Tax rules and regulations or any other applicable laws and regulations.

The Organizers reserve the right to decide on all matters.
